

**FROM A HIGHER POWER**

---

The foundation of the United States of America is the Declaration of Independence. For nearly two hundred and forty-five years that anchor of the soul of our nation has remained immovable. Lately, however, the cracks of socialism and rust of corruption are damaging the anchor. The cunning lies of the adversary have been successful in obfuscating eternal truths.

A look at the first paragraph clearly tells us that our Founding Fathers derived the power to separate from England by an inherent right bestowed by a higher power.

*“In Congress, July 4, 1776*

*The unanimous Declaration of the thirteen united States of America, When in the Course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of*

*the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.”*

The interesting thing is that generally, a person must agree with this statement to understand the Declaration from a Founding Fathers perspective. People have a right to dissolve the political bands that bind one to another. That right comes from a higher power than government or any human power. Oh, and by the way, if you want to be respectful to the opinions of others outside your circle you should declare why you are getting a divorce.

That last little bit at the end of the Declaration is quite important. The Founders knew that it is critical to a new people to achieve legitimacy. They need to lay out the legal authority according to Nature's Law. They do this in the next paragraph as they lay out the cast to determine for themselves how they ought to be governed.

The power to govern comes through the consent of the people.

*“We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, --That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness”*

It is quite a long sentence to take in, but I will try to paraphrase my read on it. We the People of the United States agree that our rights come from our Creator and that those rights are unalienable (meaning they cannot be taken away or surrendered). We all have the right to live, be free to live our

life the way we want, and we have the right to be happy.

People create governments to achieve this. They are formed to protect people from marauders or entities that seek to enslave a people. The threats emanate equally from barbarians, to soldiers, to suits. When government contradicts those tenets then a body of people have the right to dissolve that government authority over it. In the next sentence the people of the United States declare that they have carefully thought it out and they believe the offenses serious enough and they believe that they are not temporary. In light of the evidence, they have a duty to start a new government that represents their core values.

*“Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they*

*are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security.”*

The Colonists then go on to state they are essentially divorced and then go into the long list of abuses that led up to the divorce. By doing this, I believe our Founding Fathers articulate to us that they understood that the court of public opinion of the world was the determining factor on whether they were recognized as a legitimate government. This is the Jury of Nature’s Law.

The rest of the Declaration of Independence is well worth a read. When you investigate each of the grievances and study what they were about you may find that they are eerily similar to some of the oppressions we are dealing with today.

Two hundred and fifty years ago the political elite were just as corrupt and ambitious as the ones of today. It had gone on long enough and the people took matters into their own hand and published to the world their reasons why.

By understanding our past and the reasons for why we got here, we may be able to better avoid the pitfalls of today. Rights are something that comes from a higher power. We the people possess the power of self-determination, and we should be wise, cautious, and reasonable when exercising that authority.

## POWER, CORRUPTION, AND ENTITLEMENTS

---

King George III came to power after his grandfather George II died in October of 1760. In the first ten years of his reign the administration changed seven times. This political instability came at a time when the harvest was bad, unemployment was high, and cost of living was increasing every day.

A growing number of people throughout the empire were not happy with the incompetent administration, the heavy burden of taxation, and massive national debt. Entitlement programs meant to manage poverty came at a tremendous cost which forced more into poverty. Government is never efficient at anything.

It was common for people to be robbed of the fruits of their labor from cradle to grave. Many were so impoverished it forced those same people to exist on the scraps of entitlement programs filled with bureaucratic inefficiency.

A movement of personal liberty was heralded by the likes of John Wilkes, John Trenchard, and Thomas Gordon.

This “English Radicalism” was a keen source of inspiration for the people of the Americas as well.

Before the revolution, colonists had spent years under oppressive and unreasonable taxes that stripped them of their ability to live their lives. Many colonists were forced into smuggling and black-market trading just to survive. As the national debt rose the oppression increased. The divide between the have and have nots widened.

Eventually the poor were easily guilty of something every day and existed as an indebted slave class. Fear of imprisonment kept most in line. Entitlement programs were dressed up to help these same people but in fact only solidified their bondage to the state.

Our ancestors witnessed firsthand what a bloated out of control corrupt government can do

through entitlement programs. Such programs gave the government power to promote equity of outcome regardless of individual output. Through this practice a government could control its people and suppress liberty.

James Madison, our fourth President and a man known as “the Father of the Constitution”, clearly identified that these programs were not permitted by the supreme law of the land.

He states, *“I cannot undertake to lay my finger on that article of the Constitution which granted a right to Congress of expending, on objects of benevolence, the money of their constituents”*.

There are some who argue that the words general welfare in the Constitution give the government wide latitude to provide entitlements. James Madison addressed this in a letter to James Robertson.

*“With respect to the two words ‘general welfare,’ I have always*

*regarded them as qualified by the detail of powers connected with them. To take them in a literal and unlimited sense would be a metamorphosis of the Constitution into a character which there is a host of proofs was not contemplated by its creators.”*

Thomas Jefferson also spoke about how limited government is supposed to be.

*“Congress has not unlimited powers to provide for the general welfare, but only those specifically enumerated.”*

By paraphrasing that into today’s words we can simply say our government does not have unlimited power to hand out all these entitlements, but can only do the things listed in the Constitution.

It is now established that the entitlement programs are not supposed to be. Why then do they exist? The answer to that is corruption.

Two hundred and fifty years ago, most of the populace living in the Colonies had a strong moral

standard of right and wrong based on Gospel teachings of Biblical origins. Even during times of strong moral foundations, entitlement programs enslaved instead of liberated people.

When a person or class of people are given control over the substance of the lives of others, corruption is born. From that point it metastasizes into a cancer. The same corruption that plagued England and her Empire in the late 1700's is plaguing our world today.

As we look around our world everyone seems to have a price. With enough money you can get just about anyone to change their mind or vote. Today entitlement programs are enshrined into the American psyche. This has catastrophically diluted the importance and power of unalienable rights. Greed dilutes the honor that is required for liberty to function.

A whole class of people are fundamentally afraid of speaking out against things they do not agree on because they might lose their

entitlement, or worse be branded as a radical.

The most interesting part about this journey is how little I knew about history. I understand it now in a whole new way. Our ancestors went through the same struggle that we are going through now. It is the same struggle that has been going on from the foundation of time. Are we to accept the chains of bondage for the illusion of security, or are we inclined to declare liberty upon our mind, body, and soul?

## THE FOUNDERS ON HUMAN RIGHTS

---

In 539 B.C., Cyrus the Great, first king of ancient Persia, conquered the city of Babylon with his armies. He promptly freed the slaves, issued a proclamation declaring that everyone had the right to choose their own religion and he established racial equality. His decrees are preserved to this day on the Cyrus Cylinder.

Moses led the Hebrews out of bondage when he could have ruled over them as Pharaoh. The Mayflower carried a mere one hundred and two persecuted souls to the land of freedom. Rather than abandon them, the Captain stuck around through a devastating winter so the new settlers could get established.

The human spirit is willing to go through extreme measures to achieve the natural state of freedom that our bodies crave. Often it is the simple decisions of kindness done by ordinary people that create extraordinary events throughout the struggle of liberty.

Fortunately, we have some incredible records from our Founding Fathers and people who lived through the period. We do not have to invent history or misrepresent it to corrupt the minds of the youth like the 1619 Project would have you do. We turn right to the source and do not misconstrue what we find.

For an understanding of our basic human rights, I can think of no greater teacher than Thomas Jefferson, the primary author of the Declaration of Independence. Jefferson did not like to claim credit for his monumental work, but instead gave credit to those who inspired him. Montesquieu, Lock, the Scottish Enlightenment, and the long struggle for English civil liberties are but a few that he credited as his inspiration. Thomas Jefferson would be appalled at the actions of government today in the face of the medical tyranny that has taken root.

*“There is no justification for taking away individuals’ freedom in the guise of public safety.”*

Jefferson elaborated continuously about the perils of government that grows too large and eventually consumes its own populace. Our founders had firsthand knowledge of this “mission creep” as I like to refer to it. They experienced corruption and oppression on a scale that we are only now starting to acknowledge. The colonists experienced the full oppression of the British bureaucratic machine while simultaneously being harassed by the might of the British Military.

*“I think myself that we have more machinery of government than is necessary, too many parasites living on the labor of the industrious. Government big enough to supply everything you need is big enough to take everything you have ... The course of history shows that as a government grows, liberty decreases. The two enemies of the people are criminals and government, so let us tie the second down with the chains of the constitution so the second will not*

*become the legalized version of the first.”*

Jefferson fought against a strong central government and was an advocate of small, localized government. He expressed his strong opinion often. As Jefferson was a farmer from rural Virginia, his views of personal responsibility and individual sovereignty were apparent to his fellow patriots. Alexander Hamilton and other Federalists wanted Jefferson out of the picture for a smoother transition from our first government and the drafting of the Constitution. Jefferson was successful in ensuring that the Bill of Rights was adopted to the Constitution. After securing the Bill of Rights, he supported the Constitution, although he continued to speak out about the evils of big government.

It is from this background and deep thought it was recognized on many occasions by our Supreme Court, the Bill of Rights, our first ten amendments, are unable to be changed by man. They exist even if outlawed, whether chosen to be recognized by government or clergy, always in the minds and hearts of men.

What is a right? Even rock and

steel are not immutable, being fashioned by man to suit need or whim. It is the iron core of man's resolve that is truly immutable. ## REMEMBER THE LADIES

---



### Nancy Hart

Ann Morgan Hart was born around 1735 on the frontier in what would currently be either Pennsylvania or North Carolina. Most people knew this six-foot-tall muscular redheaded woman as Nancy. Her reputation as a stalwart patriot and fearsome defender against anyone who would come against her family only begins to describe the aptitude of Mrs. Nancy Hart.

In the 1770's Nancy, her husband Benjamin, and their eight children moved to the frontier of Georgia. The Broad River Valley acted as a buffer between civilization and the Cherokee bands to the north and Creek people to the south. Living in the

area during this time was not for the faint of heart. Both tribes had once fought each other over the area and were not keen on colonial settlers moving in. The tribes generally sided with the British during the war as the British promised to keep settlements out of the area. Nevertheless, Nancy's reputation for fearlessness, earned her the Cherokee name of "Wahatche", which means, "War Woman".

The supporters of the Crown were known as Tories. Nancy was a fierce fighter against the Tories in the Georgia backcountry. She had the personal ambition of ridding Georgia of all the Tories, by herself if need be. She grew so bold as to infiltrate military encampments acting like a "crazy man", so that she could gain intel on British operations.

Her husband was often away fighting with the Georgia militia, and it fell on Nancy to raise her family, provide for them, and defend against tribal aggression. Nancy was known for her keen skills as an herbalist. She was

highly skilled with a rifle and was a good tracker and hunter.

The British sent a spy to investigate the Hart family home but was discovered by one of the children. Nancy doused the spy with boiling water that was being used to make soap. She then promptly tied him up and turned him over to patriots.

There are accounts that she was at the Battle of Kettle Creek in February of 1779 and her exploits against the British brought her family more when six British soldiers stormed the farm looking for the whereabouts of her husband Benjamin. They shot her last turkey and demanded that she cook it for them as they pressured her about her husband.

Nancy's hospitality for the British on that afternoon included generous amounts of her home brewed corn liquor while the turkey cooked. She sent her daughter to get water with instructions to use their hidden conch shell to blow a signal to the neighbors and alert them to the British. When the

daughter returned, she began the task of receiving the weapons of the soldiers that her mother Nancy was sneaking out a hole in the wall. She was caught holding the third gun, but turned it on the soldiers and threatened to shoot. One of the soldiers called her bluff and rushed her. She killed him, wounded another, and the remaining four surrendered to her. When her husband arrived, he wanted to shoot them, but Nancy demanded that they hang them instead.

In 1912, a railroad excavation crew discovered the bodies of what were believed to be the six soldiers lying in a neat row. This revived the legend of Nancy Hart for a time and helped to confirm one of legends that was told about her.

Each month we attempt to pay homage to the many women who have played an instrumental role in the fight for our freedom.

## UNALIENABLE RIGHTS

---

Natural rights are an understanding of human rights that has been around since the dawn of civilization. Plato, the great teacher of Aristotle and devote prodigy of Socrates, was instrumental in capturing the viewpoints in ancient history but clear indication that Pre-Socratic philosophy also respected Natural Law as well.

Old and New Testament analysis as well as a study of “the Code of Hammurabi”, decreed by the 6<sup>th</sup> King of Babylon, shows that from the earliest points in history there was an understanding of what our Founding Fathers referred to as unalienable rights. Those Founding Fathers were a product of a nation growing up in a wilderness apart from a highly developed industrialized parent.

The colonists developed a personal understanding of unalienable rights because they existed in the perfect vacuum apart from the urbanized world of eighteenth-century Europe. They were able to experience a natural

freedom and watch as their society grew up around the natural tendency of humanity.



When the Revolution of 1688 brought the philosophy of parliamentary sovereignty to England, the colonists outright rejected it for the philosophy of constitutionalism. They were influenced by brilliant minds of the Middle Ages. Fortescue, Bracton, and Coke helped preserve fragmentary wisdom from the Roman Republic and added their own observations to refine the basic desires of liberty into a higher understanding of humanity. Their writings were often recommended to aspiring lawyers, doctors, and other advanced professions

requiring lengthy study. They are the ethics classes of the day.

As early as February 27<sup>th</sup>, 1766, a group of prominent planters adopted “Leedstown articles of association”, asserting their “fundamental rights... founded on reason, law and compact.” In 1768 the House of Burgesses, the representative assembly in the Colony of Virginia, informed Parliament that they intended to secure “full enjoyment of all our natural and constitutional rights and privileges.” Well before the first shots of the Revolution, the inhabitants of the American Colonies embraced a deeper understanding of the human condition. This continued right up to before the Revolution. On July 18<sup>th</sup>, 1774, Fairfax County in Virginia adopted the famous Fairfax Resolves where they boldly stated that their most precious rights were bestowed to them “by the laws of nature.” This document is the first one that I am aware of in our country that states that government is of the people.

Many of our Founding Fathers who were familiar with this Natural Law noted how it was reflected in Biblical teachings as well and were able to contrast the two foundations into the liberty movement. The foundational spirit and higher law are referenced in the Declaration of Independence. A deeper study of its origin and the state of mind of its architects is necessary for complete comprehension but is not practical here.

What is important to understand is that unalienable rights go back as far as recorded history. Although there are always periods of oppression, when that oppression becomes unbearable, people rise up and overthrow that oppressive state and return as greatly as possible to their natural state impeded only by the ambitions of men who seek power and influence.

Our Founding Fathers fought this same oppressive tyranny that seeks to strangle the liberties of people by obsessive overregulation, massive deficit spending to support it, and

the enslavement of citizens by overburdensome taxation.


By reaching out to our history we can begin to study the Founding Fathers that assembled the first representative government based on the principals of preserving the Natural Rights of man. Their masterful stroke against the tyranny of the English Parliament is the blueprint to secure our own liberties.

Richard Bland is a Founding Father many are not familiar with. He served as a delegate to the Continental Congress in 1774 and 1775. He was a critic of slavery and staunch supporter of natural rights. His influence in the Virginia Assembly lived on through his younger colleagues in Virginia when he died on October 26<sup>th</sup>, 1776, at the age of Sixty-Six.

Patrick Henry, Thomas Jefferson, Richard Henry Lee, George Mason, and Peyton Randolph are all key Founding Fathers who were part of that same Virginia Delegation. Virginia and its defense of Natural Law. Virginia

was one of the first to assert the Natural Rights of the people in the “Virginia Resolves” of 1765. They asserted that the power to tax and supply representatives of government rested in their own hands. James Madison was also a product of the Virginia liberty movement. Each one of those names is worthy of ten pages of brief commentary on their understanding of rights. And we have not even begun to get into the great men of Boston, Philadelphia, New York, Delaware, and the rest of the Colonies.

George Washington, James Wilson, Alexander Hamilton, George Wythe, and of course Benjamin Franklin are people we also need to understand in order to get a grasp on the understanding of unalienable rights. James Otis is someone everyone knows. Who could forget the man who was directly responsible for the birth of American independence? At least that is what John Adams, another Founding Father and second President of the United States believed.



I spoke of Otis in jest, for those that did not catch it. I did not know of him. Come to think of it, just a short time ago I did not know half of the names that I listed. Today my mind is filled with the stories of heroism and dedication from these men. I have a new, deeper understanding of unalienable rights and where they come from. Our small publication cannot hope to cover such a deep and comprehensive topic in one, let alone, three issues.

But I can promise you, if you research the names I have mentioned, you will have a deeper understanding on what it means to be free and why it is important to exercise our rights.

Our history is deliberately being erased. Look into it, study it, and share it. The answers to today's problems are in the solutions that our Founding Fathers presented to their problems. The Defense of Unalienable Rights

I say it is not the spoken or written word for which you have a right. Even the slave can whisper, and every wall scribbled a message.


I say it is not assemblage, as even men are assembled like cattle for slaughter or work or prison.

JUNE 1777

---

On the first of June 1777, the HMS *Daphne* and *Polly* entered Charlestown harbor by flying French flags. The British trick, lured in six small boats. The British took the crew and slaves as prisoners.

A few days later, Captain Woolman Sutton, a privateer from Philadelphia, who commanded the *Lively*, which was hunting for English ships. He spotted the English brig *Union* on its way to Ireland. On June 5<sup>th</sup> he captured the *Union* and sailed it to Charlestown as a prize ship.

On June 8<sup>th</sup>, the *Cotesworth Pickney*, an American privateer ship commanded by Captain William Ranking, captured the British sloop *Mary*. On June 9<sup>th</sup> he spots the HMS *Daphne* and two of her prize ships *Fanny* and *Polly* near the mouth of the St. Johns River, West Florida. The *Daphne* recaptured the *Mary* as the *Cotesworth Pickney* turned about. After a six-hour chase, she managed to lose the British.

On June 14<sup>th</sup> the prize ship Union approaching the safety of the mouth of Charleston Harbor when two British ships spotted her. HMS Perseus and HMS Galatea gave chase and outmaneuvered the Union. They managed to run her aground at Stono Inlet. The caretaker crew was no match for two fully armed and crewed British warships, and they quickly abandoned ship. The British sent out a crew that set fire to the ship and it was destroyed.

On June 17<sup>th</sup> the Samuel Spencer, Captain of the privateer St. Louis, captured the HMS Industry which was then sent to Charlestown as a prize ship.

While June of 1777 relatively quiet inland, an opportunity presented itself to the Colonial Army that caused them to muster. General George Washington learned of the British withdrawal from New Brunswick, New Jersey. On June 21<sup>st</sup> and 22<sup>nd</sup> he attempted to hamper their retreat. The action was a technical victory, but it was mired with

communication problems and poor execution.

On June 26<sup>th</sup>, 1777, General Cornwallis was under orders from General Howe to move through Woodbridge to out flank the Americans. In what became known as the Battle of Short Hill by locals, Captain James Dark led the local militia in an attack against the 5000-man British army as they made their way along Green Street and Oak Hill Road. The valiant action caused quite a commotion which drew the attention of General George Washington. His main army was standing by at the Short Hills Tavern. General Stirling, 1<sup>st</sup> Maryland Division, was instrumental in holding the line despite facing two to one odds and the heavy losses that they suffered.

I would encourage you to look up the Maryland 400 or the Washington's Immortals as they were sometimes referred to. They singlehandedly saved the Rebellion on multiple occasions.

Hello and welcome to the Patriot Resilience column of The Pamphlet. Each month we try to bring you simple tips to increase your self-sufficiency. We believe that one of the keys to our Founding Fathers success was their ability to provide much of what they needed within their communities. We encourage people to become as self-sufficient as possible while simultaneously building a network of likeminded individuals to increase community resilience.

This month I wanted to turn my attention to local maps and land navigation. This area of preparedness is often overlooked by many people. Our reliance on GPS enabled smart phones and other devices has never been greater.

For those who are hooked on their gadgets telling them where to go, may I suggest an exercise to wake your natural sense of direction? One week a month try going without directions on your electronic device. Purchase maps

so that you have them and start learning how to navigate with them.

In a long-term emergency, most people will rely on their own two legs to get around. Download some free topographic maps of the area around your home and go for walks while trying to identify the key terrain markers on the map like hills, valleys, and streams.

Invest in a few good quality compasses and always have one around. Start to get in the habit of knowing what location you are always going, and you will start to develop your natural compass.

Try to go on a walk at least once a week with a keen focus on increasing your land navigation familiarization. If you can get your body used to a once a week walk, if an emergency does happen you will be able to walk and have some basic maps skills to keep yourself oriented. Your body will thank you for the fresh air as well.

There are plenty of free guides online and low-cost secondhand books on the subject that would be

worth your time and money if you are looking to get better at navigation. Even basic familiarity and occasional usage on both motorized and land navigation with the use of maps will greatly increase your survivability in emergency situations. Power and communications are often the first to go down in disasters. Have a basic knowledge of how to get around with old fashioned maps and a compass should an implausible zombie apocalypse actually happen.

### AMERICAN COOKERY

---

Welcome to American Cookery. Our monthly column on simple recipes that can be easily made and are useful on the homestead.

This month's selection comes from Bread Making and Bread Baking. A book from Minnie E. Brothers published in 1915. It is a well-rounded cookbook that covers everything from canning to cooking and baking and is a good representation of Americana cooking from the period.

### MINNEAPOLIS BAKED BEANS

3 Cups Navy beans

6 Oz salt pork

1 teaspoon table mustard

1 teaspoon salt

3 tablespoons sugar

Few dashes pepper

One Onion (walnut sized).

Wash beans and put them with all ingredients in half gallon jar. Fill jar with cold water; bake 6 to 8 hours or all night.

I love this recipe because the ingredients can easily store a long time. It uses salt pork which was quite common before refrigeration.

You could substitute a good hunk of game meat as well. Salt pork is easy enough to make and it is a good way to start to learn how to preserve food. Here is a simple recipe.

Place 1 pork belly in a container and cover completely with sea salt and brown sugar at a ratio of 5:1. Leave in the fridge for three days or longer. For large pork bellies drain and repeat the first steps. Rinse the pork and dry it. Store wrapped in the fridge or a cool area. Soak or simmer in water before using for cooking for best results.

Salt pork stores for 6-12 months in refrigeration or you can salt cure it for long term non refrigerated storage.

Salt Pork makes some amazing home-made clam chowder as well.

Cook 6 ounces of small, cubed salt pork in a skillet with a chopped onion, tablespoon of lemon juice, a quarter teaspoon of pepper, quarter teaspoon of thyme, some crushed garlic, and a thin layer of olive oil in the pan until the onion

is caramelized. Then stir in 6 ounces of chopped clams with a couple of cans of cream of potato soup and about two cups of milk. If you do not have access to fresh clams you can use about three cans of sliced clams (drained), just reduce the milk by about a third to a half a cup. Cook on medium heat covered for a good hour stirring regularly then reduce it to a low simmer and cook uncovered for about another hour while stirring about every ten minutes.

A little Wade Chowda keeps the body warm at night. Technically there are three recipes in this section this month. Enjoy!
